Minutes of the Annual General Meeting 2022



Lohana Community North London 26th March 2023 – 15:30 Dhamecha Lohana Centre

The meeting commenced at 16:00 with prayers by the secretary, Ronak Paw, and a minute of silence for the departed souls.

Ronak Paw then introduced and invited the top table onto the stage:

- Dinesh Shonchhatra (LCNL President)
- Ronak Paw (LCNL Secretary)
- Meena Jasani (LCNL Vice President)
- Manish Sanghani (LCF Chair Person)
- Vinod Sakaria (LCNL Treasurer)
- Yatin Dawada (LCNL Immediate Past President)
- Madhu Popat (LCNL Assistant Secretary)
- Pratap Khagram (LCNL Social Secretary)
- Ashok Sodha (Election Officer).

1. Welcome by President

Ronak introduced Dinesh Shonchhatra who welcomed everyone and commented on how it had been a good day so far with 2 AGMS running smoothly on Lohana timing.

2. Matters arising from previous LCNL AGM 9th April 2022

Ronak asked if there were any matters arising from the AGM in 2022. There were no comments.

3. Approval of minutes from previous LCNL AGM 9th April 2022

The minutes of the last AGM held on the 9th of April 2022 were sent out in the AGM Bulletin 2022-2023 on pages 3-8. They were put to the AGM 2023 attendees. Geeta Nathwani proposed the approval of the minutes and Janu Kotecha seconded them.

4. Appointment of Reporting Accountant and Election Officer for AGM 2023

Ronak informed all that at the last AGM Ashok Sodha had decided to step down as the Reporting Accountant after serving the community in this role for 15 years. He was given a standing ovation by the AGM attendees. Ronak then carried on to state that the AGM attendees last year gave the Executive Committee the powers to appoint a Reporting Accountant for this year's AGM as they see fit. After an extensive search the Executive Committee approved the appointment of Dilip Unarket at their meeting on the 23rd of Feb 2023. The AGM 2023 attendees unanimously agreed with this appointment.





Ronak added that Dilip Unarket did not want to be Election Officer and as per the constitution he is able to appoint someone else as Election officer.

Therefore, he appointed Ashok Sodha who was happy to stay on as Election Officer. This again was approved by the Executive Committee at their meeting on the 23rd of Feb 2023 and was again unanimously agreed by the AGM 2023 attendees.

5. Presidents Report – Dinesh Shonchhatra

The president's written report was on pages 9-11 of the AGM Bulletin 2022-2023 but he wanted to speak too.

Dinesh started off with Jai Shree Krishna and Jai Jalaram.

He stated he was pleased to serve as the LCNL president for 2 years and that the time has gone so fast that he won't know what to do with the spare time now. He thanked Ronak Paw for arranging the AGM meeting and for the AGM 2022 minutes. He also thanked Ronak for putting together the AGM magazine and saving the community thousands of pounds in design and print costs by having them emailed out by Amit Chandarana. Thanks went to Sundeep Ruparelia for making printed copies of the magazine available on the day of the AGM too.

Dinesh congratulated the incoming Mahila Chairperson, Archana Sodha and the incoming YLS Chairperson, Tulsi Tanna. He also thanked his committee that has been the backbone of his two years in charge as well as the 6 operating bodies led by their chairpersons: Geeta Nathwani – Mahila, Urmila Thakkar – Senior Ladies, Chandu Rughani – Senior Men, Meera Majeethia – YLS, Bharat Sodha – RCT and Manish Sangani LCF.

Dinesh then thanked various people:

Pratap Khagram the Social secretary for his work in all the events. Meena Jasani the Vice President for always being at events. Vinod Sakaria the treasurer for keeping good accounts of the money and for his selfless seva over the last 9 years as he will be stepping down as the Treasurer. The Digital team of Amit Karia, Amit Chandarana, Jeet Rughani, Sanjay Rughani, Rishi Raja, Jai Ruparelia and Ronak Paw for keeping everyone informed about all LCNL and operating body events. Pratibha Lakhani and the Activity team for doing so many great events over the last two years. All the past presidents, DLC and RCT trustees for their help and guidance. Devendra and Hasmukh for their support and management of DLC. All the sponsors, volunteers and advertisers.



The outside committees, Vinu Kotecha, Ramesh Devani, Naren Hathi and the bereavement team, golf team, table tennis team and yoga team. He continued his thanks by thanking Dilip Unarket and Sunil Patel for looking at the accounts.



Ashok Sodha for being Election officer and reporting accountant for the last 15 years as well as his help with golf. Dhiraj Kataria for collecting the records of LCNL.

Dinesh then moved on to talk about Waitrose and that we should not take it for granted that we can park there. They lock the gates when they close. We have to ask them when we need to use it and now with the development work going on there, we only get a few spaces so we should look for alternative parking. If we do use it then we should only park in the designated areas and not directly in front of their shop or in the electric charging bays or disabled bays. He thanked Vinod Thakrar for liaising with Waitrose. Membership has always been close to Dinesh's heart and so he was very pleased we had over 160 new members during his two-year term but he pointed out that a lot of work is needed on the database to clean it up. Over 500 people do not have email addresses registered with us.

Dinesh thanked Sadhna and told all how she had been his rock. She was by his side at every event over the last two years.

Dinesh presented some awards to those that could not make his farewell party – Jeet Rughani, Amit Karia, Yatin Dawada and Dhiru Savani. Dinesh also thanked Jeet for his help with speeches over the last two years.

Finally, he wished the incoming committee all the best.

Ronak thanked Dineshbhai for his report and then asked if anyone had any comments or questions. Amee Karia commented that the speech was very funny and others should do speeches in this way too going forwards.

Janu Kotecha proposed a vote of thanks and asked all to stand and applaud Dinesh for his hard work over the last two years. The AGM 2023 attendees gave a standing ovation to Dinesh. Janu Kotecha also congratulated Archana Sodha for being elected the new Mahila Chairperson. Janu Kotecha also asked the secretary to send out a copy of the constitution. Ronak commented that this is something that we were looking to do anyway and will ask the new committee to take this on board.



Koki Vasani came forward to make a comment about the Jubilee Mela. She said that the senior ladies celebrated the previous Queen's Jubilee and pulled out documents from 2012.



She said no one mentioned the senior ladies and commended them for this. She was not allowed to speak at the Platinum Jubilee event about this either as she wanted to say that the senior ladies have celebrated the previous jubilee along with their 15-year anniversary at RCT and VIP lounge in 2012. She also brought up the fact that the Ageing Population has no mention of Senior Ladies from Lord Popat. Ronak thanked her for bringing this up but also questioned the relevance of this in the AGM 2023 and in the Presidents Report.

There were no other comments or questions on the Presidents Report.

6. Secretary's Report – Ronak Paw

The Secretary's written report was on page 12 of the AGM Bulletin 2022-2023 but he wanted to just add how Dinesh has covered most things he was going to say but he just wanted to point out that over the two years there has been over 100 events by the team and that's some achievement.

7. Treasurers Report – Vinod Sakaria

Vinod announced that his report is on pages 15 & 16 of the AGM Bulletin 2022-2023 and that the accounts are on pages 48-58.

Vinod went through the income and expenses and confirmed there was a net surplus this year of £49,751. Ronak clarified that this includes the £30,000 that is paid monthly to DLC and so the actual profit this year is just under £80,000 before the payment to DLC. Vinod added that YLS are giving LCNL £5,500 and Mahila are giving £3,500 and so the LCNL committee agreed at the last meeting on the 24th of March 2023 to make a proposal to give a total of £40,000 to LCF. Ronak put this proposal to the AGM Attendees and clarified this includes the money from YLS and Mahila plus another £31,000 from LCNL to make a total of £40,000.

Sanjay Chandarana asked why only £31,000 from LCNL why not more? Vinod Sakaria replied that we need working capital for upcoming events and we still need the money to pay £2,500 a month to DLC. Sanjay Chandarana said there is £108,000 in cash held by LCNL and that we should give more. Ronak asked him to suggest an amount and Dinesh stated that this is not all in LCNL's account. Some of this balance is made up of Mahila money and YLS money too.





Therefore, the committee made a decision to top the money to £40,000 and then review this on an ongoing basis. Vinod Thakrar pointed out that money is transferred to LCF at various points of the year.

Its not just at the AGM and so this can be reviewed in the future. Sanjay Rughani added that we regularly review this as a committee but we need to keep a reserve too. Janu Kotecha pointed out that the President and Secretary do attend DLC and LCF meetings and when they have had a surplus, they have donated money. He urged RCT who hold a substantial fund to also support LCF with a donation or loan. Vinod Sakaria said he has been in touch with the RCT chairperson and discussions have taken place on this subject. Mansukh Raichura commented that we are one family and so should all look to contribute to each other when needed.

Ronak proposed that we give this £40,000 for now and then regularly review this. It was put to the AGM attendees and unanimously agreed.

There were no other comments or questions on the treasurer's report.

Sanjay Rughani proposed the approval of the accounts and the treasurers report, and Janu Kotecha seconded them.

8. Social Secretary's Report – Pratap Khagram

Pratap's report is on page 17 and 18 of the AGM Bulletin 2022-2023. Pratap just thanked everyone for supporting LCNL and coming to the events in bigger and bigger numbers. There were no comments or questions on the report.

9. Membership Secretary's Report – Ashok Dattani

Ashok's report is on page 19 of the AGM Bulletin 2022-2023. He had nothing to add so the AGM 2023 attendees were asked for comments and questions.

Ashok Sodha said that the database has improved but a lot of clean-up work is needed on things like spouses' names and emails. Amit Chandarana replied that work is being done on this and they are trying to tidy the database.

Bhavna Dattani asked how do you know that you are not a member or that a youngster must join when they are 18. Ronak replied that its your own responsibility to join or not join. The website and the constitution have information on who is a member. Sanjay Chandarana added that its an individual own responsibility to join and keep up to date on the rules.

There were no other comments or questions the report.





10. Lohana Charitable Foundation (LCF) Report – Manish Sangani The LCF report is on page 21 of the AGM Bulletin 2022-2023 and the accounts are on pages 62-65.

Manish clarified that LCF looks after the building and has had its accounts audited and filed with all relevant bodies. The build costs for DLC is £4.6m and the valuation is now £6.5m but this is not a professional valuation.

Manish continued that he is grateful to LCNL and the operating bodies for the £40,000 pledge and confirmed that all of this £40,000 will be used towards paying off the loan. The loan stands at £360,000 at present and so will come down with this £40,000. The current interest rate is 8.5%.

Manish also clarified that the £2,500 a month given by LCNL is towards the running costs of DLC. All the work carried out at DLC is to appropriate standards. The hall is being regularly hired out but the costs are growing and that's why there is now a cost of £350 for holding a prathna at DLC. Manish pointed out that when we first purchased the hall LCNL pledged that prathnas will be free. This is not a charge to hire the hall but to cover costs. Manish thanked the President and his team on behalf of all the LCF trustees then opened the floor for any questions or comments on his report.

Janu Kotecha wanted to clarify that the £350 cost was only for Lohana's at that all others would be charged a different rate for hire of the hall depending on their requirements. He also added that this does not include the PA system. Manish confirmed this is just for Lohanas and that people were free to hire a PA system of choice.

Naina Raithatha asked why people need to hire a PA system and why we can't have an inhouse one. Manish said this has been looked at but it's not that simple. If we buy the equipment someone still needs to run it but it is something that is constantly being looked at.

Ronak commented that he does not agree with the £350 charge for prathna. It should be free for LCNL Lifetime Members and not others. He also pointed out that when people call, they are quoted £530 not £350 as the PA system fee of £180 is forced on people. Rishi Raja added that bhajans singers often bring their own sound and also that sometimes you are told that you cannot use the bhajan singers you want. You have to use only the ones the Bereavement team want you to. Manish said that any PA System can be used and that the charge was to cover rising costs and will be reviewed in the future. Vinu Kotecha also claimed that Rishi was wrong in what he stated about bhajan groups and he will clarify this more in the Bereavement report.





11. RCT Report

The LCF report is on page 20 of the AGM Bulletin 2022-2023 and the accounts are on pages 66 and 67.

There were no comments or questions on this report.

12. LCNL Mahila Report

The Mahila report is on pages 22 -23 of the AGM Bulletin 2022-2023 and the accounts are on pages 68 – 70. There were no comments or questions on this report.

13. Senior Mens Report

The Senior Men's report is on pages 24-25 of the AGM Bulletin 2022-2023. There were no comments or questions on this report.

14. Senior Ladies Report

The Senior Ladies report is on pages 26-27 of the AGM Bulletin 2022-2023. There were no comments or questions on this report.

15. YLS Report

The Young Lohana Society (YLS) Senior Men's report is on pages 28-29 of the AGM Bulletin 2022-2023. There were no comments or questions on this report.

There were no other comments or questions on any subcommittee reports apart from Bereavement and Ageing Population.

16c. Ageing Population – Yatin Dawada

Yatin wanted to say thanks to Sanjay Rughani as he joined the team after that report had been written.

16d. Bereavement Committee – Vinu Kotecha

Vinu Kotecha wanted to make some comments about the Bereavement team. He started by saying that some families take advantage of the team and abuse them. He has been doing this seva for 24 years and now because of zoom kids have forgotten their Dharma. They look at death as a function.





The 16 Sanskar's are very important but the youth do not see this. He thanked Ramesh Devani for being his right-hand man and Yatin Dawada for stepping in while he was away. He also thanked Amit Karia for helping him get set up on zoom and Manisha who has stood by him too.

Vinu Kotecha then pointed out that he felt Rishi was wrong when he said you are not allowed to use any bhajan group you want. He said that they recommend certain groups because others are a rip off. He tells people to use bhajan singers that do not charge. Vinu Kotecha then went on to say that only when you have a death in the family do you realise how difficult it is and then turn to the community for help. He did 142 funerals last years which he felt saved people £35,000 as they did not have to pay mahraj or other people to do the funeral and he also did 190 prathnas which again saved the community money. He has never expensed his travel or time but it shows how much money the team have saved LCNL.

Vinu Kotecha also made a point about how prathna and bhajans are different. Bhajans are heard by Bhagwan but a prathna is heard by the soul. The Bereavement team do not say no bhajans they are just saying use the groups that will sing appropriate bhajans. Vinu Kotecha moved on to talk about how he always recommends Mokshe as a funeral director. Its because they have helped out lots of families with free funerals when they cant afford them.

Vinu Kotecha ended by saying none of this is directed at the EC or any committee member but was just for the public to be aware.

Vinod Sakaria added that Vinu Kotecha came with him to Belgium for a funeral and prathna and did so of his own expense.

Rajni Sawjani added that all the team give seva and they do it for the community. People will always speak as its easy to speak but hard to act.

Ronak commented that its not fair to talk about time put in as we all put time in and none of us expense anything. We all do seva for the community. He then suggested that the incoming committee have a meeting with the bereavement committee to work out some of these issues.

Vinu Kotecha stepped in to say he would be happy if someone comes forward to take over the bereavement team. He also said it's the first time he has mentioned time and money in 24 years.



Janu Kotecha commented that Vinu Kotecha does a great job and that the new committee should sit down with the bereavement team and work this all out.



Yatin Dawada added that he covered Vinu Kotecha for 10 days and is exhausted so it just shows how good a job Vinu Kotecha has done.

It was agreed that the incoming committee will sit down with the bereavement team and seek to iron out any issues.

17. AOB

AOB 1 – Disability – Sukeshi Thakkar

Sukehsi Thakkar requested the new committee look at a disability affiliation. Ronak said that this was a great idea and something that the incoming committee should look at.

AOB 2 - RCT conversation - Sailesh Mehta

Sailesh Mehta wanted to clarify that the conversation held by the treasurer with regards to RCT funds was only with the Chairperson and not the RCT committee. The minutes above reflect this.

AOB 4 – Thanks to Vinu Kotecha's team – Geeta Nathwani

Geeta Nathwani wanted to thank Vinu Kotecha and his team for their help serving food at Navratri and other events. She asked for a round of applause from the AGM attendees who duly obliged.

AOB 5 – RCT Clarity – Jeet Rughani

Jeet Rughani asked for clarity about RCT, why it was formed and how it sits with LCNL. Whilst he has some knowledge on this, he felt there needs to be a education piece on this for the whole community. This is something that LCNL can ask RCT to do.

AOB 6 - Money - Ronak Paw


Ronak Paw pointed out that the committee should be allowed to spend money as it sees fit. If some money is spent on team building or celebration events this should be fine. But recently there was a Presidents farewell party where guests and volunteers were invited that had helped the community during the pandemic and did not charge for their time. It was agreed by the EC that we would ask for contributions but that LCNL would pay for the rest. But this was leaked out to the public and Past Presidents and others said that it was not ok to use LCNL money for this. Ronak felt it was embarrassing to ask someone to attend an event to say thanks and then tell them to pay for their own meal. Dipak Jatania said that in all his years on the committee the farewell party is always paid for by donations and by the president himself. Ronak said that's not right to have a farewell party that you pay for yourself and said in future the Executive Committee should be able to decide themselves how and where money is spent as long as they are not taking it too far.

Presidents Report Meena Jasani - LCNL President

Respected Elders, Ladies & Gentlemen, and the members of LCNL,

I am thankful to the founder LCF trustees, Manishbhai Sangani and Pratibhaben Lakhani for their invaluable service to the community since the acquisition of the building in 2011. Their tenure finishes on 14/4/2024 but I am sure they will continue to support the community when required. I am pleased to report that on 29th June 2024, it will be 10th anniversary of our building since its inauguration during the period when, I was the President of LCNL.

The trust board of Lohana Charitable Foundations Ltd (LCF) oversee all attributes of our community building. Dhamecha Lohana Centre Ltd (DLC) is a 100% subsidiary of LCF who manages the operational matters including security, health & safety, maintenance, bookings, and finance. I am thankful to all the LCF Trustees, DLC Directors, LCNL President Meenaben Jasani and the Executive committee for their guidance and full support. The community events held by LCNL at DLC are of very high standards and the external bookings have increased considerably. I am pleased that record numbers of attendees participate at numerous events at DLC. I would also like to encourage our community members to book the centre for their family events which will help to generate additional income for the community.

The Directors with the guidance from LCF Trustees continuously monitor all the regulatory, health and safety and security requirements. We constantly carry our repair and maintenance and cleaning activities to maintain a high standard. We make sure that the centre caters for the needs of the community and the quality demanded for the external events. We are currently reviewing capital investments in Solar Panels and Audio visual.

This year was the first year where, we made a small profit of £12,000 after rent payment of £100,000 to LCF. We are thankful to LCNL for contributing £30,000 p.a. towards the usage for the community events. They have recently paid an additional £45,000 which has enabled us to repay the bank loan by extra £50,000. The current loan with Metro Bank is around £260,000 (Loan on 5/4/2023 £360,000) Our aim is to repay the loan asap as the interest rates are very high at 9.25% p.a. We are confident that with the support of LCNL and the community, we will make DLC debt free soon.

I am thankful to the LCF trust board for electing Vinod Thakrar (LCF Chairman), Janu Kotecha (LCF Secretary) and Deepak Jatania (LCF Treasurer). The LCF and DLC accounts for the year 2023 are fully audited by KLSA LLP and submitted to the authorities. The extracts of both the accounts are published in this bulletin.

Aging Population Chandu Rughani & Yatin Dawada



What is Ageing Population?

Due to medical advancements, people are living longer, which will result in an ageing population explosion in the coming years. There are several questions that arise from this.

- What health issues are there?
- What planning is required by LSC (Senior Men and Senior Ladies)?
- Are we ready as a community for the increase in the number of people with dementia, memory loss, and other related conditions?
- Will the government help, and if so, for how long?
- Will the NHS be able to cope with it?
- With the experience of caring for the elderly in the pandemic, it is quite evident our senior citizens prefer to be independent and are reluctant to be a burden on the family. How can we help them to be independent? What support can we provide them?

There were numerous challenges, and we had no answers for them. In 2019, Chandubhai Rughani, the Chairperson of LCNL Lohana Centre (Senior Men), and the President of LCNL at that time, Yatin Dawada requested the assistance of prominent Lord Dolar Popat. He has extensive knowledge in this field and produced a report entitled 'The Ageing Population in the Lohana Community' after several hours of research and reaching so many different people.

This report was well received across the globe. The recommendations have been reviewed and gradually implemented under Chandubhai's leadership as the chairperson of the Ageing Population. Due to the size of the project, each recommendation was discussed in detail and priorities were determined. The tasks involved:

- Prioritize the challenges.
- Establish a project team to commence working on priority challenges.

The Dementia project was launched last LCNL term under Prof. Bhik Kotecha's leadership, based on this concept. Several dementia events were organised, and all received positive feedback.

This term, we are continuing with Dementia under the leadership of Dr Dipa Modi and have also launched the Loneliness project under the chairmanship of Prof. Bhik Kotecha.



Dementia 2024 Project

The AP Dementia team held a successful medical camp for dementia in March 2023 at the Dhamecha Lohana Centre.



More than 300 people attended the event. Out of the 104 individuals who were screened for dementia, 9 were found to have a positive result. This was unknown to some of the 9 individuals.

In January 2024, we held a very successful zoom dementia webinar in Gujarati & English. Dr Jitendra Kakad discussed risk factors, symptoms of dementia, and the advantages of early diagnosis.

Dr Dipa Modi discussed how dementia is a lifestyle disease. Additionally, 15 natural methods for reducing and reversing dementia were discussed based on current evidence. Jyotiben Joshi discussed the social stigma associated with dementia and how best to care for those suffering from it. Also, the need for care for the caregiver which may be a family member.

Finally, Professor Bhik Kotecha gave an update on the dementia camp held at the Dhamecha Lohana Centre in March 2023.

The response to this webinar exceeded our expectations, and the zoom reached its maximum of 1000 capacity quickly. There was excellent feedback and we received hundreds of requests for viewing the recording. The recording is available on YouTube by searching for LCNL Dementia. Currently, it has been viewed by 2.8K. The participants come from diverse communities. In addition, we have been asked by 174 participants to inform them of future dementia events.

Furthermore, a synopsis of this dementia webinar was published in the Gujarat Samachar & Asian Voice Magazine.

In February 2024, the LCNL Ageing Population Dementia team was invited to present a similar presentation live on Nusound Radio. This was courtesy of the presenter Kanji Ghedia. Over 17000 Gujarati listeners from all over the world tuned in, making it a great success. Once again, positive feedback was received.

Further work is ongoing in planning future programs on legal and financial aspects, how to provide better care, and question and answer sessions. Please watch this space.







Loneliness 2024 Project

Prof Bhik Kotecha is the chairperson of this project.

On July 12th, 2023, a Zoom session titled 'Loneliness: Medical, Social, and Spiritual Perspective' was organized. The main speakers were Prof. Bhik Kotecha, Mr. Vinodbhai Kotecha, Mrs. Rashmiben Mapara, and Mrs. Jyotiben Joshi. The attendance surpassed our expectations and was well-received.

A variety of proposals were discussed to address loneliness. One proposal was to organise a social/musical evening to raise funds to help both the Dementia and Loneliness group. In particular, the Dementia group had pledged this to Alzheimer's Research group and it was suggested that some of the funds raised could be used by LCNL to support the Loneliness group activities.

1.14 Group accounts


